# Communication



**Development of a strategic communication plan is necessary.**

- Connect with students daily (online plan)
- Provide weekly feedback on student work (online plan)
- Help families understand their role in supporting their child's continuous learning
- Create and communicate consistent messaging for families through School Status, Facebook, Twitter, school's webpage, etc.
- Throughout our communications, stress best prevention practices, our school district's vigilance, and how families can stay informed through health websites like the CDC or the Mississippi State Department of Health.

# Establish Routine Cleaning Schedule

Frequently touched surfaces will undergo cleaning with a commercially available cleaning solution multiple times throughout the day,



Light switches, doors, benches, bannisters, bathroom fixtures



Surfaces & objects, labs and other settings where "hands-on" material and equipment are used



Student desks cleaned before and after each use

# Attendance

- Develop and communicate a wellness policy for students and staff that require sick students and staff to stay home
- Adhere to MDE guidelines on attendance



# Entry Plan

- Students will enter and exit in single-file lines to enable physical distance.
- Establish one or two entry and egress points that enable the flow of students to move in a single direction
- No visitors allowed in building, except under extenuating circumstances, in which they must wash or sanitize hands prior to entering.
- Establish hand hygiene stations at facility entrance (sanitizer with at least 60% alcohol
- School safety officer will assist with monitoring of a safe and secure environment.

# Health Contingency Plan

- Daily temperature/health checks of all entering the school (Healthy at Work minimum requirement)
- All staff and students trained on health and safety requirements
- Maintain daily record of students and staff in the building
- Identify isolation room and prepare procedures to safely send staff or students home if ill
- Prohibit access to water fountains
- Limit bathroom use to a number that aligns with social distancing requirements
- Require proper handwashing and hygiene. Hand sanitizer required for students prior to starting any work within the facility
- Face masks required to max extent possible in all areas of the school (classroom, arrival, dismissal, and any other transition within the building)

# Health Contingency Plan

- Scheduled handwashing with use of soap & water or sanitizer required of students and teachers every 2 hours as well as at the times found in CDC guidance (arrival, before and after eating, and exiting/dismissal)
- Gloves required of custodial staff or any teacher or staff when cleaning their classrooms
- Display COVID-19 informational signs in highly visible locations (school entrance, restrooms)
- Intensify Cleaning and Disinfecting Efforts
  - Ventilation: Ensure ventilation systems work properly and increase circulation of outdoor air as much as possible
  - Water Systems: Drinking fountains will be covered. Students and staff will be encouraged to bring their own water.
